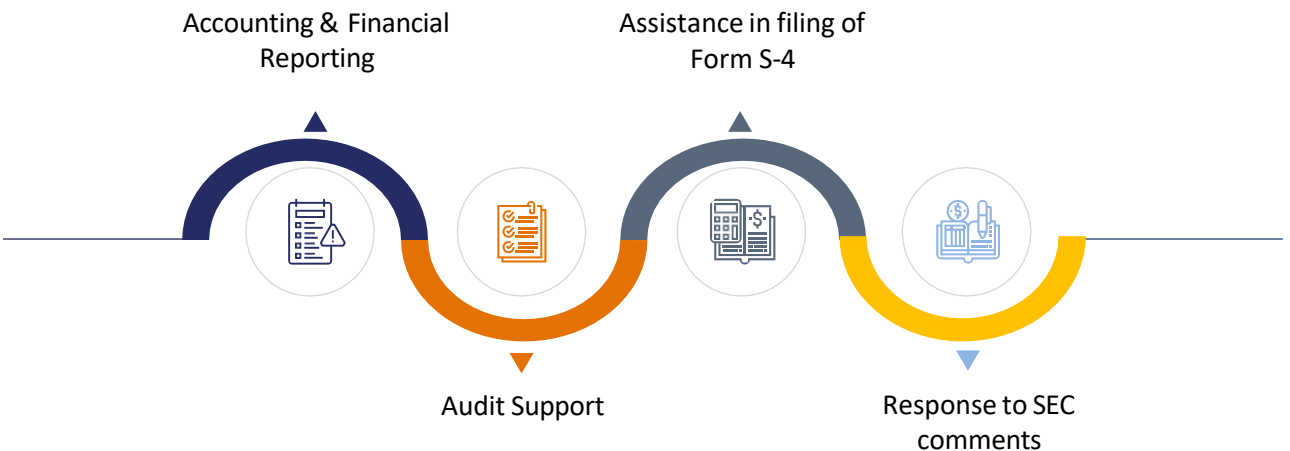

Accounting & Financial Reporting

- Collating the accounting data of parent and its subsidiaries from the respective accounting teams. subsidiaries from functional currency to reporting currency.
- Carry out USGAAP-related adjustments, eliminations and closing entries to enable the consolidation. Preparation of USGAAP consolidated financial statements supported by detailed schedules for each line item.
- Continuously engaging with the accounting teams to resolve the queries which smoothen the whole process.

Assistance in filing form S-4

- After ensuring the smooth closure of Audit, the team was extensively engaged in drafting and finalizing the Form S-4 with respect to the client's data.
